Participant Agreement: Terms & Conditions

IMPORTANT! PLEASE READ THE FOLLOWING RETREAT PARTICIPANT AGREEMENT & TERMS AND CONDITIONS CAREFULLY. ONCE YOU HAVE READ THE TERMS AND CONDITIONS FOR YOUR BOOKING, PLEASE COMPLETE, SIGN AND RETURN YOUR FORM TO US PROMPTLY TO SIGNIFY THAT YOU HAVE READ UNDERSTOOD AND ARE WILLING TO ABIDE BY THE CONDITIONS OUTLINED BY THE TERMS & CONDITIONS OF THIS AGREEMENT.

NOTE: If you plan to participate in more than one Immersion, you will be required to complete and return a Participant Agreement for each. If there is more than one person included in your booking, please ensure that a Participant Agreement is completed and signed for each person. By signing and returning this Participant Agreement, you Leanne, The Barefoot Medium Executive Director of Barefoot Academy agree to the following:

Booking Policy

1. A booking is confirmed on an immersion with Leanne, The Barefoot Medium and Barefoot Academy once the non-refundable, non-transferable deposit of \$500 is paid via the web site (Paypal).
2. If a booking is made less than 6 weeks prior to the start date of the immersion the entire amount is required to confirm your place.
3. You understand that it is your responsibility to ensure you are medically and physically fit to participate in the immersion. If you have a disability, pre-existing medical condition, injury, illness or medical history requiring special attention or treatment, it is your responsibility to advise Leanne, The Barefoot Medium and Barefoot Academy at the time of booking and are advised to consult with medical specialists prior to reserving your space and participating. If you are unable to attend alone or require special assistance or handling, you must be accompanied by a companion who can provide the required assistance. Leanne, The Barefoot Medium and Barefoot Academy assume no responsibility for cases such as these.
4. You understand that you must complete and sign a copy of the Terms and Conditions as outlined and the Disclaimer and Wavier in every respect prior to engaging in the Immersion. Failure to provide this may result in the cancellation of your space and the cancellation policy outlined below will apply.
5. You must be at least 18 years of age to attend immersions with Leanne, The Barefoot Medium and Barefoot Academy - unless accompanied by a guardian 18+ years old and approved prior
6. By making payment of your deposit or full payment to Leanne, The Barefoot Medium and Barefoot Academy, you are accepting these Terms and Conditions.

Payment Policy

1. All prices outlined, unless otherwise stated, are in Australian dollars.
2. All prices are subject to availability, subject to change and can be withdrawn or varied without notice.
3. Price changes may occur for reasons outside of our control which increases the cost of the product or service provided, including (without limitation) services from suppliers.
4. You agree to provide payment to Leanne, The Barefoot Medium and Barefoot Academy of the fees indicated for the Immersion as described and outlined on the website at the time of booking and/or by the due date indicated.
5. Payment must be received in full by the nominated due date(s) prior to the immersion commencement. Failure to pay within the nominated time-frames will result in the deposit being forfeited and your space being resold.
6. The balance of your immersion payment is due to Leanne, The Barefoot Medium and Barefoot Academy via the web site (Paypal) or direct bank transfer no later than 6 weeks prior to the commencement.
7. Bookings within the last 6 weeks of the immersion commencing must be paid in full at time of booking via the web site (Paypal).
8. Any bank fees incurred by transferring money are your sole responsibility.
9. You are responsible for all extra services not included in the immersion in cash or where facilities allow credit card payments can be accepted.
10. Payment of the immersion fees does not include:
 - Any flights or other transportation from your home to the location
 - Any meals not listed on the website.
 - Personal laundry, telephone calls, personal hygiene products etc.
 - Any beverages or alcohol
 - Any other item unspecified as included in the Immersion

Cancellation Policy

1. Any and all cancellations must be received by Leanne, The Barefoot Medium and Barefoot Academy in writing via email as soon as practical.
2. Any and all requests to transfer a booking to an alternative immersion date or another person must be received by Leanne, The Barefoot Medium and Barefoot Academy within 8 weeks of the Immersion commencing in writing via email and where approved must be used within 12 months from the original booking.
3. If payment of either the deposit or the balance is not received by the relevant due date Leanne, The Barefoot Medium and Barefoot Academy reserves the right to cancel your reservation and retain your deposit and any additional fees imposed by suppliers

4. You must submit your signed Participation Agreement within one week of booking or 30 days prior to the Immersion start date, whichever comes first. Failure to sign and return this form, may result in the automatic cancellation of your space and the above policy will apply.
5. In the event that you cancel your booking, regardless of the circumstances Leanne, The Barefoot Medium and Barefoot Academy will not issue a cash, cheque or credit card refund of your deposit for any reason. The following refund policy, minus the deposit, applies (deposits are non-refundable, as mentioned above):
 - Prior to final payment: Your deposit is forfeited
 - After final payment: There will be no refund of your deposit, in addition any fees imposed by suppliers, which may be up to 100% of monies paid
 - After commencement: There will be no cancellation once the Immersion has commenced and no refund of any unused services. Requests for refunds received after commencement will not be accepted.
6. Leanne, The Barefoot Medium and Barefoot Academy reserves the right to change its offer, individually agreed services, location or venues due to extraordinary circumstances (e.g. external forces, governmental regulations, delays of third parties, weather and oceanic conditions, etc.) or other unforeseen issues (e.g. third party delays or problems, construction, etc.) beyond our control. Alternative arrangements will be made where possible and the standard of alternative locations, venues or services will be kept the same in all circumstances. Where any essential component of the Immersion is changed, you will be notified in writing via email as soon as possible. The itinerary and agenda can change at any time without notice.
7. If Leanne, The Barefoot Medium and Barefoot Academy cancels or changes a scheduled Immersion date for any reason, you may transfer your payment to another Immersion within a 12 month period (pending availability) or you may request a full refund of your payment. Leanne, The Barefoot Medium and Barefoot Academy is not responsible for any expenses incurred in preparation of a cancelled Immersion, i.e. airplane tickets, other transportation, insurance, taxes, illness, loss of work or other supplier costs etc.
8. Leanne, The Barefoot Medium and Barefoot Academy does not accept responsibility for any additional travel, supplier or other costs incurred, including airfares, other transportation, insurance etc, as a result of changes or cancellations.

Note: Exceptions to Leanne, The Barefoot Medium and Barefoot Academy cancellation policy cannot be made for any reason. We do not offer any credit for arriving late or departing early, missing activities or not utilising any part of the program.
